- 4. Parking Restrictions/Issues: Evian Patterson, DDOT

In response to numerous residents in 5D05 and 5D02 complaining about parking changes and ticket issuance Evian Patterson was asked to address the community. The Commission requested that all parking fines issued for 1800-2100 Maryland Ave, 1230 Bladensburg Rd and 1700 block of Holbrook Street NE be suspended until the matter could be sorted out. Mr. Patterson said that DDOT had not changed the parking signs along Maryland Ave or Bladensburg Rd, but simply replaced missing signs. Discussed the handicap parking permit process; residents need to provide a doctor's certification to apply. Mr. Patterson was unable to address the parking ticket issue and promised to return to the next Commission meeting with responses

Planning to file for a modification with the Zoning Commission; Henderson moved that ANC 5D send a letter of support to the ZC in support of the request, Dumas seconded, passed 5-0

Treasurer moved to accept the report, pay all bills, properly documented reimbursements and approve the 3rd quarterly report, seconded by Blacknell; passed 5-0
