- Assaults are up, most are Domestic Violence related
- Disputes are over food family related
- Robberies are down
- > Burglaries are down
- 0 theft on autos
- Reminded citizens to not leave anything in their cars; to report illegal activities no matter how small
- Robbery arrest at 16th and Levis; case papered as a robbery US Attorney's office moving forward on prosecution
- > Incident on Galludet Street, Saturday at approximately 5 p.m., woman with a knife not making much since, followed people for about a block waving the knife
- > Sgt. Jones had no information regarding the incident.

Officer Travis Collins:

- A lot of the Domestic related assaults have been resulting around food in more than one property in PSA 506.
- Officer Collins will provide more information in regards to recent assaults.
- Public concern regarding suspicious activities transpiring on 19th and Benning Roads
- No updates for 507; request for updates in 507 and 505
- Concern with the open air drug activities at 19th Street corridor
- Officer on patrol sitting at 1830 Benning Road which is the Food 7 Store, there was some drug activity behind the store.
- Kudos to 5D in locating the elderly lady that was missing in 5D03.
- Missing 12 year old from the 18th Street area was located.

- 5. Tommie Jones, Ward 5 Representative, Mayor's Office of Community Affairs Mr. Jones advised that he handles issues in the Commissions of 5C and 5D; Malik Williams handles issues in Commissions of 5A and 5B they both rotate with Commission 5E.  - Mr. Jones provided information regarding Mayor Bowser's first State of DC Address to be held on Tuesday, March 31, 2015 at the Lincoln Center, at 6:30 p.m.
 - Mr. Jones made a partial announcement in regard to the newly appointed Washington, DC Fire Chief Gregory Dean who came from the Seattle Fire Department.
 - ➤ Involved with the Senators and Satchel Paige's event on February 18, for an opportunity for boys and girls from ages 4-18 to be a part of.
 - Working on a number of issues to make Ward 5 DC a great place to grow to feel safe and learn. We do work with Commissioners and have opportunities to be engaged. Working with individuals during neighborhood clean-up. Working with the PSA's to help reduce crime and other activities that have been going on.
 - Commissioner Roberts ask about any opportunities for DPW or the Mayor's office would like to get public comments on like improvements for next year any suggestions.
 - Mr. Jones suggested that Commissioners could email him directly or if the Constituents emailed the Commissioners they could forward to them and they would make sure things were taken care of.

6. Presentations

- Monument Academy Emily Bloomfield, Founder and CEO Laura Masimini, Outreach Coordinator for Monument Academy, informed us of a new upcoming weekday boarding school, Monument Academy serves students who are at risk of expulsion suspension and other punitive infractions in traditional school systems.
- Academic, social and emotional education; located at the Rosedale Gibbs building- 19th and Benning Roads, NE; Schedule and brief overview of curriculum was shared with meeting attendants

- 1. Is there a plan in place for students to thrive during the IEP?
 - There is a personalized plan for every student
- 2. Is the Boarding School floor plan accommodating a mixed gender population?
 - > There will be single gender housing that holds 8-10 students per 2-3 adults
- 3. What is a comparison between other boarding schools?
 - Family Style setting versus a traditional dormitory style
- 4. Funding
 - Public Charter School
 - Support is needed by bringing families
- 5. Psychiatric Health/Special Education availability
 - Hired Director of Well Being
 - Hire 3 Licensed Social Workers for each grade level
 - Full Time Psychiatrist

- Again gave summary of project and requested support for a stipulated license for opening in late April 2015.
- It was brought to the attention of the Commission that Commissioner Lewis had not yet had Mr. Puesan to present his project in front of her constituents in a scheduled SMD meeting.
- ➤ Commissioner Henderson suggested that Commissioner Lewis give Mr. Tony Puesan a chance to present in front of her constituents during a scheduled SMD meeting. HR57 will be placed on the April's agenda.

Ms. Malia Salaam - Presented on DC Street Cars

- Presence of the Street Cars
- Concerns about the vehicular accidents that has taken place
- Wants to raise awareness about how to interact safely with the Street Cars
 - $\circ\quad$ It takes the Street Cars at least 60 full feet to stop if it's just moving 20 mph.
 - It can actually go as fast as 35 mph but will rarely see that. Street Cars has to follow all regular traffic signals with exceptions of 4 locations, Starburst;

Western Turnabout by the Giant on top of the hopscotch bridge; and two locations near Spingarn High School, one at 26 Street and the other at Oklahoma Ave.
