- **Department of Public Works**
 - Street sweeping started Monday, March 4th until October
 - Every street is taken care of in DC even in areas not covered in program
 - DPW New App Launch

 - Street signs are taken care of by DDOT, not DPW
 - Parking enforcement with street sweeping (issue from last meeting)
 - DPW does enforce that with ticketing
 - 16th St and Meigs Pl, cars covered and are not getting moved at all;
 - Looking for guidance from general counsel;
 - Enforcement can write a ticket if they observe a violation, technically can't observe the parking because of the cover
 - 311 report for illegal dumping, 5 days to get resolved
 - Cameras can get license plate, and then can give to police

- City trash cans that get full; is this illegal dumping?
 - No, but it is illegal to dump household trash in city trash cans
 - ANC5D can submit trashcan requests to Celeste
 - Foot traffic drives prioritization for which requests get new trash cans
- **Langston Golf Course Lease** presented by Maura Brophy (mbrophy@federalcitycouncil.org)
 - Mara Brophy from federal city council
 - Now pursuing competitive lease
 - Council still is trying for non-competitive
 - Federal City Council is out talking with the community, but never had control of the course
- **BZA Case 19982 at 1723 Montello Ave NE**; presented by Jamal
 - Requesting area variance relief from C-202.2 and special exception relief from C-703.2, G-405.2, G-404.1 in order to construct an addition on top of existing building footprint and provide seven residential units.
 - Affordable housing?
 - No, but will have inclusionary home unit, 80% medium income in that area
 - DC gov website has average rent for Trinidad
 - Street parking is only option for property
- **BZA Case 19972 at 1449-1451 Holbrook St NE**
 - Application of David Do, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception from the penthouse requirements under Subtitle U § 1500.4, to construct a third floor with a roof deck and a penthouse enclosure on an existing two-story flat in the RF-1 Zone at premises 1449-1451 Holbrook Street, N.E.

 - Planned Unit Development; changing zoning in order to change development plans
 - 45 acres
 - Start having conversation on building behind Union market so that they don't lose their parking which expires at end of 2019

Community Feedback

A constituent asked if ANC5D, or any Commissioners singularly, would be submitting a letter calling for Jack Evans to be stripped of his chairmanship of the finance committee and call on Council to launch an investigation, as at least 15 other ANC Commissioners have done and at least 1 ANC District has done. The request is in the wake of his current ethics scandal regarding pay-to-play politics. A copy of the letter can be found [here](#). Commissioner Burkett asked that the constituent submit this inquiry formally via email, and he will follow up.

A constituent reiterated that speakers are needed for the meeting to be accessible for all. Commissioner Shropshire said the ANC is still waiting for Security Fund approval to spend that amount, but that the ANC agrees with the need.
